The Herring Scholarship

The Herring Scholarship seeks to create opportunity for individual development for students at James Sprunt Community College who strive to prepare for productive lives and outstanding citizenship. The purpose of the Herring Scholarship is to provide support for the identified financial needs of a diverse spectrum of students who demonstrate good citizenship, high moral character, and potential for leadership. Herring Scholarship awards can be used for tuition, fees, educational supplies, and other educational expenses as approved by the Herring Scholarship Selection Committee.

Herring Scholarship Eligibility Requirements:

To be eligible for the Herring Scholarship, applicants must reside in Duplin County, North Carolina, or the Town of Mount Olive and be accepted for admission to James Sprunt Community College. To be considered for the Herring Scholarship, applicants must submit a complete Herring Scholarship Application Package to the office of the JSCC Foundation at James Sprunt Community College and complete the Free Application for Federal Student Aid (FAFSA). Applicants must currently have and maintain a cumulative GPA of at least a 2.5. The Herring Scholarship Application Package **must** include the following in order for your application to be considered:

- The Herring Scholarship Application Form
- The Free Application for Student Aid 2017-18 (FAFSA)
- Three letters of recommendation from school, business, and/or leaders in the community attesting to your character and leadership potential
- A 300 – 500 word essay (double spaced) on the people and experiences that have shaped or influenced your values and your educational and/or life goals.
- A completed James Sprunt Community College Admission application.

Selection Criteria:

Selection of the Herring Scholarship recipients will be based on financial need, letters of recommendation and personal essays. Interviews may be requested at the discretion of the Herring Scholarship Selection Committee.

Renewal Criteria:

Recipients must be in good academic standing and maintain satisfactory academic progress toward a degree as specified in the James Sprunt Community College catalog.
